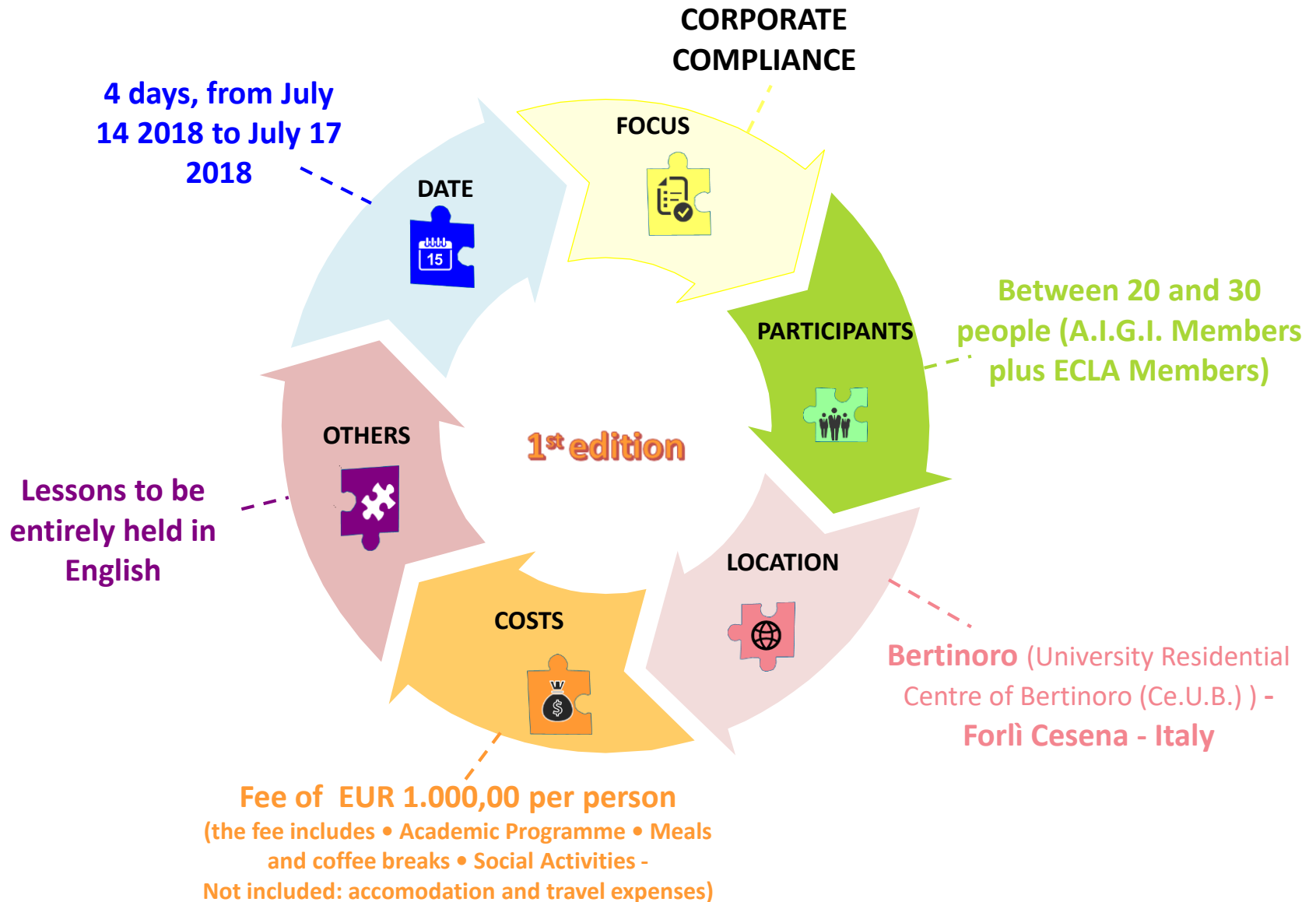
Summary

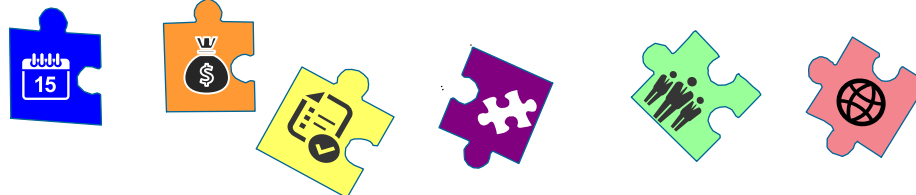

How to reach Bertinoro

by Car



A14 Motorway Leave the A14 motorway at the toll booth of Cesena, turn left and take the E45 national road (direction Rome). Leave the E45 at Cesena Ovest, turn right and take the national road n.9 (Via Emilia, direction Forlì-Bologna). Then, pass the hamlet of Capocolle and follow directions to Bertinoro.

by Train



Line Bologna-Rimini Get off at the station of Forlì or Cesena. Bertinoro is 13 km far from the aforementioned railway stations. Public transportation From the Bus Station of Forlì (Forlì Punto Bus), very close to the railway station, quite a few buses are available to reach Bertinoro. Taxis are available at the Railway Stations.

by Plane



The closest airport to the University Center of Bertinoro is Bologna (BLQ), about 80 km away.

In Rimini Airport (RMN), 40 km away from Bertinoro, some European flights are landing.
